



## **Assumption of Risk and Waiver of Liability Relating to Coronavirus/COVID-19**

Tara Mandala cannot guarantee that you or your child(ren) will not be exposed to or contract COVID-19 while attending an in-person event or being on its premises. By utilizing Tara Mandala's services and/or entering its premises, we want you to understand that there is an inherent risk of potential exposure to COVID-19. Tara Mandala urges all program participants to take responsibility for their health and wellbeing while at Tara Mandala.

All in-person event participants must sign this Assumption of Risk and Waiver of Liability document upon arrival at Tara Mandala.

1. **Agreement:** By signing this document, you agree that you and/or your child(ren) will not attend a Tara Mandala in-person event if you have tested positive for COVID-19 within 10 days prior to the event. If Tara Mandala staff requests, you also agree to take a COVID-19 test or provide proof of a recent negative test upon arrival.
2. **Assumption of Risk:** By choosing to utilize Tara Mandala's services and enter its premises, you voluntarily assume the risk of potential COVID-19 exposure for yourself and/or your child(ren). You understand this risk may arise from the actions or negligence of Tara Mandala, its representatives, or others on the premises. You accept sole responsibility for any illness, injury, loss or damages related to COVID-19 that you or your child(ren) may experience from visiting Tara Mandala. You agree to indemnify Tara Mandala against any claims that may arise from you or your family members/contacts being exposed to COVID-19 as a result of your visit.
3. **Liability Waiver:** On behalf of yourself and your child(ren), you release and waive your right to bring claims against Tara Mandala and its representatives related to COVID-19 exposure from your visit. This waiver covers claims for any

injuries, illnesses, losses or damages, whether foreseen or unforeseen, to the fullest extent permitted by law. You understand if retreatants or staff become ill during your stay, Tara Mandala is not obligated to provide refunds, credits, or compensation.

4. **Governing Law:** This agreement shall be governed by the laws of the State of Colorado.

**By signing below, you acknowledge you have read, understand, and agree to take responsibility for your own health and wellbeing while at Tara Mandala, assume the risks, and waive your rights regarding liability as described above. You understand this agreement is required to utilize Tara Mandala's services and premises in person.**
